GUIDELINES FOR ARTISTS:

1. The VENUE agrees and guarantees to pay AGENCY the total amount listed above.
2. If ARTIST is unable to perform (due to sickness, accidents, riots, strikes, epidemics, acts of God, or any other legitimate conditions beyond his or her control), AGENCY will take reasonable measures to provide a suitable alternate ARTIST.
3. GOVERNING LAW: This AGREEMENT shall be governed by the laws and in the courts of the State of Arizona and by the laws of the United States, excluding their conflicts of law principles. Any dispute or legal proceeding regarding the AGREEMENT shall take place in the County of Pima, in the State of Arizona.
4. This contract constitutes the sole, complete, and binding agreement between the AGENCY(s) and the VENUE.
5. Members of unions or guilds, which may include leader and members of this unit, agree to accept sole responsibility for complying with the rules and regulations of said unions or guilds of which they may be members.
6. This agreement and option shall be considered renewed at the end of the period herein unless AGENCY receives a written notice with the intent to terminate this contract. Any questions relating to this agreement shall be interpreted in accordance with the laws of the State of Arizona.
