1. The undersigned group (hereafter referred to as The Band) hereby employs your agency as our non-exclusive personal representative and agent for the term commencing on the above date and continuing thereafter for a period of 3 months.
2. As a personal representative, your duties shall be the following: to use all reasonable diligence and make all reasonable efforts to assist The Band in negotiating for and procuring employment wherever The Band 's services are available to accept such employment, and to use all reasonable diligence and make all reasonable efforts to assist The Band in promoting said employment.
3. You hereby accept this employment and agree to perform your required services for The Band during the aforementioned term. It is expressly understood and agreed upon, however, that you shall have the right to render your services to other groups or individuals, either in a capacity similar to that in which you are hereby employed, or otherwise.
4. As consideration to you for your acceptance of this employment and for your agreement to perform your required services, The Band agrees to pay you, after being received by The Band, a sum equal to twenty percent (20%) of the gross compensation received from any employment or performance you procure for The Band during the aforementioned term. If an employment or performance was procured during the aforementioned term but falls outside of the aforementioned term, The Band agrees to pay you, after being received by The Band, a sum equal to twenty per cent (20%) of the gross compensation received as long as you use all reasonable diligence and make all reasonable efforts to assist The Band in promoting said employment.

5. It is agreed that if you submit to The Band an offer in writing for an employment or performance and The Band fails to accept such offer, within the term of this agreement, but thereafter, and within a period of six (6) months from the date upon which you submitted the offer, The Band accepts an offer on substantially the same terms, then in that event it shall be deemed to have been consummated during the aforementioned term and you shall be entitled to compensation as previously stated herein.
  
6. The Band acknowledges that no officer or representative of your agency other than yourself has any right or authority to make any statement, representation, promise or inducement which is not herein expressly set forth, and that this instrument constitutes the entire contract between us.
  
7. The execution hereof by you and The Band will constitute this instrument a valid and binding contract between you and The Band, and this instrument may not be amended or changed in any respect except by written instrument executed by both you and The Band.
